Senior Officer – Information Technology

The applicant must possess

- (1) a recognised degree in Information Technology or other related disciplines;
- (2) a minimum of 5 years' post-qualification work experience in application development, with no less than 3 years at system analyst level;
- (3) familiarity with the whole software development lifecycle;
- (4) in depth knowledge of system design by using UML & OO design pattern, multi-tier and web-based applications with Microsoft .Net MVC, C#, Visual Basic, CSS, JavaScript Libraries / frameworks, Windows Workflow Foundation, LINQ, WCF, Entity Framework, Crystal Report, Microsoft SQL and Mobile Apps cross platform development;
- (5) excellent analytical and troubleshooting skills with good project management, documentation and problem solving skills;
- (6) ability to complete highly detailed tasks with attention to quality, completeness and timeliness;
- (7) excellent communication and interpersonal skills; and
- (8) excellent command of both written and spoken English and Chinese.

(Applicants who do not possess the required qualifications and / or experience may be considered for other positions within the organisation.)

Duties include

 to act as System Analyst to provide on-going application support and be involved in various stages of system design and development cycles;

- (2) to translate complex business process into system requirement by analysis, design, building system model and preparing specifications;
- (3) to support the team in defining project requirements, tracking and documentation in accordance with CIC project methodologies and policies;
- (4) to conduct user requirement analysis for development and / or implementation of new systems and existing systems enhancement;
- (5) to participate in system development and design, application evaluation, systems integration and migration;
- (6) to manage projects and programmers to produce quality and timely deliverables; and
- (7) to carry out any other duties as assigned from time to time by the Executive Director.
