## The applicant must possess

- a minimum of 10 years' post-qualification work experience in engineering / surveying / architecture or other construction related fields; experience in supervising subordinates is preferred;
- (3) profound knowledge in project planning and management; solid experience in enhancing construction productivity will be an advantage;
- (4) a high level of integrity and a sense of responsibility;
- (5) strong interpersonal skills;
- (6) proactive, resourceful, creative, energetic character and can work independently; and
- (7) excellent command of both written and spoken English and Chinese.

(Applicants who do not possess the required qualifications and / or experience may be considered for other positions within the organisation.)

## **Duties include**

- to provide the assistance in taking up the duties to support the initiatives for enhancing the productivity performance of the construction industry;
- (2) to provide support to the CIC, the Committee on Productivity and task forces in undertaking assignments;
- (3) to initiate and manage research and consultancy projects funded by the CIC;
- (4) to liaise with the stakeholders and relevant parties for the implementation of research and

consultancy outcomes;

- (5) to prepare work plans, study briefs, research reports, papers, guidelines, standards, documents of technical nature as well as any other relevant documents for enhancing the performance of the industry;
- (6) to supervise subordinates; and
- (7) to carry out any other duties as assigned from time to time by the Executive Director.
