## 1.1 Confirmation of the Progress Report of the 2<sup>nd</sup> meeting held in 2009

Members took note of Paper CIC/CTB/R/002/09 and confirmed the progress report of the 2<sup>nd</sup> meeting held on 25 March 2009.

1.2.2 Agenda item 1.4: Full-time Adult Short Course on Buildings Repair and Maintenance Course

Members noted that the first class of the above course would start in July 2009.

1.2.3 Agenda item 1.5: Action Plan for First Phase of Construction Industry Youth Training Scheme

Members noted that the working group of the above scheme would follow up the formulation of performance indicators and the corresponding measures. The budget estimates for the scheme would be submitted to the next meeting of the Committee on Administration and Finance for consideration.

1.2.4 Agenda item 1.6: Progress Report of 'Civil Trades Cooperative Training Scheme' co-organized with contractors

Members noted that a joint venture construction company had submitted a preliminary proposal on a training scheme for 6 TBM Operators and details and arrangements of the proposal are being As regards the leaflet of 'Civil followed up. Trades Cooperative Training Scheme' tabled at the meeting, Members opined that content of the leaflet should not restrict the types of trades that might be included in the training scheme and training proposals should be initiated by those trade contractors when they identified training needs. Proposals submitted should be evaluated by the management and then be considered by the The revised promotional leaflet could be circulated to Members for consideration.

1.2.5 Agenda item 1.8: Certificate Course for Construction Materials Sampler (Revalidation)

Members noted that since the relevant government department had already included the course name in public works contracts and amendments were considered inappropriate at the moment. Member also noted that the teaching of construction materials sampling had already been included in the full-time supervisor programmes.

1.2.6 Agenda item 1.10: 'Safety Training Revalidation Course for Construction Workers of Specified Trade (Silver Card Course)' for two specified trades

Members noted that case analysis had already been added to the content of the 'Curtain Wall Installer Silver Card Course' and the 'Lift Mechanic Silver Card Course'.

1.2.7 Agenda item 1.15: Revision to test questions of 'Asphalter (Waterproofing)'

Members noted that the revised test questions would be used from June 2009 onwards whereas the test certificates would specify the waterproofing materials used by applicants during the tests.

1.2.8 Agenda item 1.19: Short-term tenancy of the Tin Shui Wai Training Ground (No. 2290)

Members noted that the Construction Industry Council Members would sign the above tenancy agreement whereas the tender report concerning the setting up of the venue would be submitted under a separate agenda item.

1.3 Capacities for Basic Craft Courses and Supervisor/ Technician Training Programme for 2009/2010 Training Year

Members took note of Paper CIC/CTB/P/032/09 and approved the total capacities of 533 and 266 places for Basic Craft Courses and Supervisor/ Technician Training Programme respectively for the 2009/2010 training year.

Members however pointed out that the above proposed training capacities should be reviewed in the light of the actual situation that building works had been diminishing while civil works were on the rise at the moment. current arrangement of offering basic craft courses, which were mainly on building works, on a regular basis every year need to be changed. A Member also opined that CICTA should break away from its past practice because it was not required to focus on recruiting S.3 and S.5 school leavers for basic craft courses and supervisor courses To better meet the needs of the industry, the respectively. provision of relevant training by the contractors and subsequent accreditation of the courses by CICTA could be This was especially feasible for the training considered. of supervisors. Basic training provided by CICTA together with practical working experience gained on sites would enhance the skills and the competency of trainees of the supervisor courses. This arrangement would help ensure that the training capacities would satisfy the market demand because trainees would be recruited and training would be provided by contractors only when there were actual manpower demands.

In addition, the presently approved capacity of about 260 training places (including 1<sup>st</sup> year and 2<sup>nd</sup> year) of supervisor/technician courses was only a ceiling. CICTA was required to consider the allocation of training places on civil works and building works according to the actual needs. Meanwhile, CICTA was requested to actively follow up the future direction of having training provided by contractors with partial subsidy from CICTA and implement the proposal as soon as possible.

As regards the basic craft courses, a Member expressed that secondary school leavers should not be the main target trainees of the said courses in view of the implementation of the 3+3+4 New Senior Secondary Curriculum. According to previous intake figures, local teenagers were ioin quite reluctant the construction industry. to Therefore, CICTA should re-consider its recruitment targets and target at the new immigrants and ethnic minorities. There was also a need to review the demarcation between basic craft courses and short courses. In addition, the arrangement of offering classes on a regular basis had to be revised as appropriate. A Member reiterated that the type of class offered had to match market needs. Meanwhile, it was also opined that an academic/career ladder had to be developed for all trainees.

Members noted that the Buildings Department had already given CICTA its consent to re-launch the TCP 1 course for experienced supervisors who did not possess the academic qualification. It was expected that the first class would be introduced in August 2009.

## 1.4 Trainee allowances of basic craft courses and supervisor/ technician programme for 2009/2010 training year

Members took note of Paper CIC/CTB/P/033/09 and agreed that the trainee allowances of basic craft courses and supervisor/ technician programme for 2009/2010 training year would be maintained at the 2008 level as below:

## 1.5 Training capacity and trainee allowances of full-time adult short courses for 2009/2010 training year

Members took note of Paper CIC/CTB/P/034/09 and agreed that the daily trainee allowance of \$90 of full-time adult short courses would be maintained for the 2009/2010 training year. Members however would approve the training capacity of the courses concerned subject to supplementary information to be submitted by CICTA. Members also opined that CICTA should stop the practice of specifying training places for individual trades and instead adopt a more flexible way with the approved capacity as the ceiling and type of classes to be offered according to the actual demands of individual trades.

(Post-meeting note: CITB had already endorsed the training capacity of about 1,300 places for full-time adult short courses for 2009/2010 training year on 10 June 2009 by circulation of paper.)

### 1.6 Training capacity and schedule of part-time courses for 2009/2010 training year

Members took note of the Paper CIC/CTB/P/035/09 and endorsed the proposed capacity of about 60,000 places for part-time courses for the 2009/2010 training year.

Members also expressed that CICTA might in the future consider submitting the total capacity as a ceiling for CITB's consideration. As regards the breakdown of the capacity, CICTA could make the necessary adjustment according to the actual circumstances of the industry in the year.

#### 1.7 Tower Crane Worker's Assistant Training Course

Members took note of Paper CIC/CTB/P/036/09 and endorsed the introduction of the above full-time adult short course in the second half of 2009 as well as the manpower and other resources required. The course duration would be 75 days and there would be 12 persons in each class. Meanwhile, the daily trainee allowance would be \$90. Certificates would be issued to those trainees who had an attendance rate of 95% or above and passed the course assessment.

## 1.8 **Tower Crane Routine Inspection and Maintenance Training Course**

Members took note of Paper CIC/CTB/P/037/09 and endorsed the introduction of the above part-time course in the second half of 2009 as well as the manpower and other resources required. Course fee for each trainee would be \$400. Certificates with a validity of 5 years would be given to trainees who did attend the 1-day course and pass the written test. After 5 years, a half-day revalidation course had to be taken and a written test to be passed before a renewal of another 5 years could be made.

## 1.9 Certificate Course in Metal Scaffolding (Civil Engineering and Building Construction)

Members took note of Paper CIC/CTB/P/038/09. As the course component, the intermediate trade test, of the above certificate course co-organized by the Employees Retraining Board and CICTA only accounted for just 40% of the total mark, Members opined that CICTA should ensure that relevant techniques and safety standards, which were highly regarded by the construction industry, should always be the key factors in assessing whether a trainee could be awarded a certificate in the course of securing subventions from the Employees Retraining Board for conducting courses.

### 1.11 Promotion and advertising activities for 2009 full-time courses

Members took note of Paper CIC/CTB/P/040/09 and the presentation of a final year case study on 'Trainee Recruitment Plan for Full-time Courses of Construction Industry Council Training Academy in 2009' undertook by the School of Communication and Department of Marketing of Hong Kong Baptist University.

Members suggested that all promotional activities had to tie in with the actual circumstances at the time. For example, the commencement of relevant promotional and recruitment activities in response to the launch of public works would bring about the desired promotional effect. CICTA was required to conduct a market research to collect the views of related parties like industry practitioners and recipients so as to formulate specific promotional strategies and directions.

#### 1.12 Proposal to purchase a brand new tower crane

Members took note of Paper CIC/CTB/P/041/09, and agreed to purchase, rent or lease-purchase a tower crane, for which a sum was already earmarked in the yearly budget estimates, by means of open tender. The tender documents were also accepted. Due to the fact that tender assessment was divided into two components, i.e. technical and price scores, Members suggested that if the tower crane specifications provided by the tenderer could satisfy the minimum requirement on the technical aspect, the price difference would be the sole factor to be considered.

# 1.13 Proposal to change the venue for conducting the E&M trade tests to be taken back from Vocational Training Council by Construction Industry Council Training Academy

Members took note of Paper CIC/CTB/P/042/09 and decided to take the original proposed option of using Kwai Chung Training Centre as the venue for conducting E&M trade tests subsequent to a study on the viability, sustainability and potential for expansion of all the options proposed. It was agreed that to conduct the E&M trade tests to be taken back from the Vocational Training Council in Kwai Chung Training Centre would be more cost-effective than to set up E&M trade test workshops in the Management Training and Trade Testing Centre. Also, the former venue would have more room for further expansion.

## 1.14 Construction Workers Registration Authority's request on CICTA to add sub-divided trade tests into the trade tests of certain designated trades

Members also agreed to apply for additional provision from the Committee on Administration and Finance because the number of applications exceeded the quota under the original subsidy scheme. Taking the provision required for the new plan into account, an additional provision of \$860,000 in total was required in 2009, which would be submitted to the Committee on Administration and Finance for approval.

After discussion, Members agreed to award the building construction contract of Tin Shui Wai Training Ground to Wide Project Engineering & Construction Company, which had the highest combined scores covering the technical and price aspects. The tender price was \$4,887,110 and an additional provision of \$2.15 million would be sought from the Committee on Administration and Finance as capital expenditure for the setting up of the Tin Shui Wai Training Ground.
