	2. The Council will use the information provided for levy assessment purposes and will handle it in accordance with Section 61 of the Ordinance. Under Section 67 of the Construction Industry Council Ordinance, the Contractor / Authorized Person who gives false documents or information to the Council for levy evasion purposes shall commit an offence and shall be liable on conviction to a fine at Level 3 or 3 times the amount of levy that was evaded or intended to be evaded by his conduct, whichever is the greater. 根據《建造業議會條例》第67條，任何承建商／獲授權人若規避徵款而提供虛假的文件或資料給予議會，即屬違法。一經定罪，可被處第3級罰款或該人藉其行為規避或意圖藉其行為規避的徵款的款額的3倍，兩者以款額較大者為準。
