This study material is a reference for candidate to prepare for attending written test in Intermediate

Trade Test:

1. The symbol shown in the diagram represents level.

- 2. Surface finishes work should be start at 7 days after completed the rendering coat.
- 3. The function of groove/drip line is to intercept the flow of rainwater.
- 4. Before tiling, an ideal rendered wall surface condition is even and vertically straight.
- 5. During tiling with mosaic tiles on floor, the function of tile-to-tile joints is to prevent thermal expansion and contraction.
- 6. In general, the minimum height of dado is 600mm.
- 7. The function of expansion joint on floor or external walls is to relieve the effect of thermal expansion and contraction.
- 8. Aligned work surfaces across different walls refer to working surfaces are aligned to become a straight line.
- 9. Tiles laid like shoe fitting floor mirror refer to tiles laid at chamfer between wall toe and floor.
- 10. When laying mosaic tiles on wall, it is commonly start from bottom part of the wall.
- 11. To lay mosaic tiles on bottom edge of the lintel for window, the correct method is to set correct position and measure the levelness of tiles.
- 12. Before tiling, two reference lines with intersection angle of 900 will be marked on the floor for setting out purpose.
- 13. To measure verticality, plumb bob is commonly used.
- 14. The function of plaster's joint rule is to refine the joint between mosaic tiles.
- 15. According to Construction Sites (Safety) Regulations, no person should enter a construction site unless he/she is wearing a suitable safety helmet.

- 16. Every board or plank forming part of a working platform should be not less than 25mm in thickness.
- 17. After finishing works in everyday, tools and work site should be cleaned.
- 18. The proper attitude towards boss at work is to realize the job requirements, follow the instruction given by your supervisor and seek for advice if any queries.
- 19. The function of the safety shoe is to protect the feet.
- 20. In case of foreign object in the eye, clean water should be used to flush the foreign object out of the eye.
