### 1.1 Confirmation of the Minutes of the Previous Meeting

Members confirmed the minutes CIC/ENV/M/004/23 of the last All to Note Com-ENV meeting No. 004/23 held on Friday, 8 December 2023.

### 1.2 Matters Arising from the Previous Meeting

The CIC Secretariat updated Members on the following matters:

(a) Item 4.3 — ★Consultancy Services on the Development of Strategy and Plan Directional Guideline for the Hong Kong Construction Industry Achieving Carbon Neutrality Target according to the Hong Kong's Climate Action Plan 2050

Members approved the release of the stage payment to CECEP following the approval of Paper \*CIC/ENV/P/016/23\*.

### 1.3 Progress Update on CIC Smart Waste Management Tool

Members were briefed that the SWMT would be ready for industry use since the green light has been obtained from the Development Secretariat Bureau, and the CIC would encourage more projects to use the Tool.

The establishment of linkage between iBeam and SWMT would be completed by first quarter.

Members were apprised that engagement with URA and BD were conducted to promote SWMT.

Members were briefed on the proposal of the SWMT Phase Two Development. During the discussion, Members made the following suggestions: (1) conduct a desktop study on alternative construction methods, tools, and services to replace the use of timber and timber formwork in local construction sites; (2) maintain continuous engagement with key stakeholders from different disciplines, including relevant authorities, architects and authorised persons, throughout the platform development; and (3) consider inviting representatives from the developers and main contractors sectors to join the working group.

Members approved Paper CIC/ENV/P/004/24, which included the Assignment Brief, the Project Plan and proposed Working Group membership, for the Consultancy Service on Phase Two development of the CIC SWMT.

# 1.4 Proposal on a Feasibility Study on Construction Site Electrification and Clean Energy Adoption

Members were briefed on proposal for the consultancy service on the Feasibility Study on Construction Site Electrification and Clean Energy Adoption. During the discussion, Members made the following suggestions: (1) engage two power companies to discuss on the allocation of temporary power to individual construction sites, as well as the power supply plan for remote sites; (2) include the scenario-based study on power demand during different phases of construction for various types and locations of projects; (3) consider recruiting extensive industrial expert(s) in the field of construction site electrification and clean energy adoption for the consultancy; (4) explore potential incentive and funding options; and (5) consider embracing a vision ahead of other countries and cities in this area, and (6) study the measures to staggering power consumption at construction sites.

Members approved Paper CIC/ENV/P/005/24, which included the tender document, assignment brief, project plan and timeline, stakeholder engagement list for the consultancy service on the Feasibility Study on Construction Site Electrification and Clean Energy Adoption, and the proposed replacement for the Working Group membership.

# 1.5 Enhancement of the Assessment Mechanism and Procedures of the CIC Research and Technology Development (R&D) Fund

Members were briefed on enhanced assessment mechanism and procedures for R&D Fund applications, including (1) increase the frequency of application openings per year; and (2) improve the efficiency and flexibility of the assessment process by forming an Assessment Panel consisting of members from the four CIC Committees. Members expressed their support for the proposal in principle and recommended that the CIC Secretariat continues to collaborate and liaise with other partner organisations. Members also suggested determining the roles and responsibilities of each organisation, establishing specific conditions, evaluating investments required, maintaining data accuracy, and devising a plan for sustaining the platform.
