2.27 Confirmation of Minutes of the Previous Meeting (Open-door Session)

Members referred to Paper CIC/CMT/M/001/24 and confirmed the minutes of the open-door session of the 1st meeting of 2024 held on Friday, 23 February 2024 at the Board Room, 29/F, Tower 2, Enterprise Square Five (MegaBox), 38 Wang Chiu Road, Kowloon Bay, Kowloon, Hong Kong.

2.28 Matters Arising from the Previous Meeting (Open-door Session)

The Chairman invited MYP to brief Members on matters arising from the last Council Meeting No. 001/24. MYP reported as follows:

Item 1.27 As a follow up to the visit to the buildingSMART International Standards Summit – Lillestrom 2023, a hybrid event, "Accelerating openBIM Adoption for Built Asset Industry" had been held at the CIC Digital Twin Hub on 1 December 2023 to share members' experience on the visit and report the latest development of openBIM in Hong Kong. Besides, the CIC would support the openBIM Regional Summit 2024 to be held in mid-June 2024 in Hong Kong by further promoting the use of openBIM and implementation experience sharing of local projects through i-Club. Council/Board/Committee Members would be invited to join the Summit.

Item 1.29 A working group had been formed to work on a survey on industry safety awareness. The kickoff meeting would be held on 24 April 2024.

2.29 Summary Notes of 1st Meeting of Committee on Building Information Modelling and Construction Digitalisation for 2024

AHKK briefed Members on the Smart Site Safety System Labelling Scheme targeted to be launched in May 2024 with the aim of enhancing the wider adoption of the Smart Site Safety System.

In response to the Chairman's enquiry on whether the supply of BIM personnel could meet the market demand, AHKK briefed Members on the supply and demand of BIM Managers and BIM Coordinators with a PowerPoint presentation. It was noted that as of March 2024, the estimated demand and supply of CCBMs were very close. However, the supply of BIM Coordinators was far below the estimated demand. If the number of graduates (i.e. trained BIM personnel) who had not yet applied for certification was also taken into account, the supply of trained BIM Coordinators would exceed the demand.

BIMCAB Secretariat

Members shared their views on the general situation of the supply of BIM personnel in the market, which were summarised as follows:

- (a) they had not been informed of any significant issues regarding the availability of BIM personnel in the market when needed;
- (b) some Members mentioned that some companies outsourced BIM-related work to the Mainland;
- (c) more promotional work should be carried out to attract people, specifically young ones, to enter the field and receive training on the use of BIM technology in order to meet the increasing demand in future;
- (d) more trained BIM personnel should be motivated to apply for certification, such as approaching their employers in the private sector;
- (e) a survey could be conducted to gather information from graduates of BIM training courses on their career paths and the factors affecting their decision, which could be leveraged in formulating appropriate strategies; and

(f) greater efforts should be made to enhance the local and international recognition of CCBMs and CCBCs to attract more people to apply for certification after graduation.
