Other recommendations from Members were included in the Assignment Brief. A tender was issued on 22 May 2024 for closing on 12 June 2024, aiming to appoint a consultant in June 2024 to start the study.

		 (c) <u>AOB item – Proposal on Green Data Hub</u> The CIC Secretariat maintained close liaison with the Hong Kong Green Building Council (HKGBC) and BSL to build a unified data platform for existing tools. Detailed proposal would be completed around Q3 to Q4 of 2024 for discussion. (d) <u>AOB item – Proposed on ESG Initiatives</u>
		The CIC Loyalty Programme was proposed to be integrated into the CIC APP. Cross- departmental deliberations would be carried out to develop a comprehensive proposal for Members' discussion.
2.3	PowerPoint Presentation (for information)	Progress Update on HKGBC Projects funded by the CIC and funding request for 2025 Members took note on the progress updates of the 2024 funded projects and HKGBC's funding request for 2025. Members were also updated on the progress of the enhancement project to the CIC Green Product Certification (CICGPC).
		Members agreed on the inclusion of the four proposed new product categories, namely Glazing, Precast Concrete, Aluminium, and Renewable Energy Systems - Solar Panels, to the CICGPC. HKGBC was suggested to conduct a thorough review on the criteria to ensure that they are appropriately challenging yet attainable so as to drive market growth.

2.4	CIC/E&S/P/008/24 (for approval)	 2025 Business Plan & KPIs The CIC Secretariat presented the detailed business plan and budget with KPIs for 2025. Members agreed to allocate budget to the studies and tools for decarbonisation in the industry, including (1) Feasibility Study on Construction Site Electrification and Clean Energy Adoption; (2) Smart Waste Management Tool Phase Two Development; and (3) CIC Carbon Assessment Tool. Members suggested deferring the timeline and seeking alternative collaborative opportunities for the CIC Loyalty Programme in case of insufficient budget. Members approved Paper CIC/E&S/P/008/24 outlining the detailed business plan and budget of HK\$11.55 million with the KPIs for 2025.
2.5	CIC/E&S/P/009/24 (for approval)	 Progress Update on Smart Waste Management Tool Members were informed of the progress of the CIC Smart Waste Management Tool (the "Tool"). The Tool was launched in April 2024, accompanied by ongoing promotion efforts by the CIC Secretariat and Arcadis. The tender for Phase 2 Development, which includes a study on timber/timber framework, would be closed on 24 June 2024. Members approved Paper CIC/E&S/009/24 covering the Final Report of Phase 1 Development and the release of stage payment of HK\$372,000 for the Final Report.
