4.1	CIC/RSC/M/003/24 (for approval)	Confirmation of the Minutes of the Previous Meeting Members confirmed the minutes of the previous meeting held on 29 May 2024.

4.3	CIC/RSC/P/052/24 (for endorsement)	Com-RSTCS 2025 Key Performance Indicators, Work Plan and Budget After deliberation, Members endorsed the 2025 key performance indicators, work plan and budget of the Com-RSTCS and endorsed the major work direction of exploring ways to strengthen the arrangements for avoiding the registration of "dummy companies", optimising management training and enhancing integrity management.

4.4	CIC/RSC/P/053/24 (for information)	Follow-up Report on Proposed Addition of "Site Surveying" as a Designated Trade Members noted that following the last meeting, the Secretariat had promptly met and clarified with representatives of the Land Surveying Division of the Hong Kong Institute of Surveyors (HKIS-LSD), the Hong Kong Institution of Engineering Surveyors (HKIES) and the Lands Department on the registration requirements for the public works contracts of the Development Bureau (i.e., works outside the scope of work in relation to the designated trades or trades under the RSTCS does not need to be undertaken by registered companies), and had conducted several rounds of communication. After deliberation, the Com-RSTCS approved the refinement of the scope of the designated trade "S12 Levelling and Setting Out" to better demonstrate CIC's original intention of regulating "Job Lines Setting Out" subcontractors, and requested the Secretariat to follow up with the relevant institutes and the Development Bureau on the publicity work so as to allay the concerns of the surveying service companies.
4.5	CIC/RSC/P/054/24 (for information)	RSTCS Operation Report Members took note of the Operation Report. As of end of June 2024, the total number of registered companies was 7,186 (April 2024: 7,271) in which 2,785 (April 2024: 1,708) were Registered Specialist Trade Contractors and 4,401 (April 2024: 5,563) were Registered Subcontractors. The Secretariat planned to organise a series of activities in the latter part of 2024, highlighting the webinar of integrity risk in the construction industry, the Executive Training Series for Young Leaders Network and the RSTCS leadership summit to be held on 19 November 2024 with the theme of "new quality productive forces".
