5.4	CIC/RSC/P/069/24 (for information)	Draft "Alert on Management of Wage Payment Records in Construction Industry" Members took note that the Executive Director hosted a forum on 30 August 2024 with leaders from major industry stakeholders including Development Bureau, The Hong Kong Construction Association, The Hong Kong Federation of Electrical and Mechanical Contractors, The Hong Kong Electrical & Mechanical Contractors' Association, Hong Kong General Building Contractors Association, The Hong Kong Registered Contractors Association, Hong Kong Construction Sub-Contractors Association, Registered Specialist Trade Contractors Federation, Hong Kong Construction Industry Employees General Union, The Federation of Hong Kong Electrical & Mechanical Industries Trade Union and The Hong Kong Construction Industry Employees General Union. They exchanged views and explored in depth the causes and solutions of the problem of payroll disparity and reached a consensus on dealing with related problems together. In view of the problem of payroll disparity might stem from deficient arrangement of wage payment records, the attendees unanimously agreed on producing an "Alert on Management of Wage Payment Records in Construction Industry" (the Alert) to remind industry stakeholders on good practices of managing wage payment records for upholding integrity and implementing the related good practices. Members then deliberated on the draft Alert and approved in principle to issue the Alert, while requesting the Secretariat to consult the above-mentioned trade associations and trade unions on the refined draft in regard to the comments collected at the meeting before promulgation.

5.5	CIC/RSC/P/070/24 (for information)	Members noted that as of the end of August 2024, the total number of registered companies was 7,265 (June 2024: 7,186) in which 2,800 (June 2024: 2,785) were Registered Specialist Trade Contractors and 4,465 (June 2024: 4,401) were Registered Subcontractors. The Secretariat continued co-organising seminars with various stakeholders, including the Land Surveying Division and Quantity Surveying Division of the Hong Kong Institute of Surveyors, ICAC, etc., to promote the latest information of designated trades of the Scheme, integrity management, etc. A series of executive training courses would be held for management personnel and young leaders of registered companies of the Scheme on 26 September, 3 and 17 October 2024 with the themes of corporate ESG, leadership experiences and contractual legal practices to allow their interactions with the speakers and building up of business network. The biennial RSTCS Leadership Summit would be held on 19 November 2024 afternoon at CIC-ZCP with the theme of "Set Sail with New Technologies" for sharing practical experiences on adoption of new technologies by pioneer subcontractors.

5.8	CIC/RSC/P/071/24 (for information)	Follow-up Report on Suspected Non-compliance Cases Members noted that the Secretariat had issued reminder letters to seven registered companies which had been referred by relevant departments for suspected but not convicted late payment of wages.
5.9 & 5.10	CIC/RSC/P/072/24- CIC/RSC/P/079/24 (for approval)	Regulatory Action The Com-RSC imposed a total of thirteen regulatory actions of suspension of registration and written warnings due to violation of the relevant legislations concerning the collection of illegal introduction fees from workers by ex-employees, late payment of wages and MPF contributions as well as late submission of workers daily attendance records of respective registered companies.
