		effect for nearly a year and recent feedback from industry stakeholders, Members, after much deliberation, considered cases were appropriately handled in the past but the procedures could be optimized to cater for special circumstances and approved the following items: i) added the re-established Sub-Committee on Regulatory Actions to the procedure to deliberate first any special factors of the case as if raised by individual Member and to make recommendations for the Com-RSC to make the final decision; ii) the appointment of members to the Sub-Committee on Regulatory Actions and its revised terms of reference; and iii) the optimized internal procedure would take effect from 1 January 2025, after being reported to the Council.
6.4	CIC/RSC/P/088/24 (for information)	Report on the Optimization of Registration Arrangements for the Designated Trade of "Truss-out Scaffolding (TOS)"
		Under the leadership of Mr. Lawrence Ng, the Chairman of the Task Force on Truss-out Bamboo Scaffolds (the Task Force) under the Committee on Construction Safety, and after multiple rounds of discussions with various stakeholders, the registration of the designated trade of TOS was proposed. After much deliberations and noting that the Task Force and representatives from the Development Bureau would meet with representatives from the Property Management Services Authority to seek their support for implementing the CIC TOS registration arrangements, Members agreed to hold a special meeting in December to discuss the outcomes of the Task Force's meeting and to meet with representatives from major scaffolding trade associations first, then for further discussion on approving the new TOS registration with the prior target on starting the registration from 1 January 2025.

		A series of three "Executive Training Courses of the Young Leaders Network" were successfully held on 26 September, 3 October and 17 October 2024, with a total of 252 young leaders and industry leaders attending in person. The three speakers respectively focused on themes of corporate sustainability, leadership innovation experiences, and practical contract law management (including an introduction and preparation for the Construction Industry Security of Payment Bill) and well engaged with the participants.
		Members noted the comments received from various young leaders and the Secretariat was meeting with various employers and industry associations to consult industry stakeholders on refinements on registration requirements and conduct reviews based on market conditions.

	(for information)	Members noted that as of the end of October 2024, the total number of registered companies was 7,147 (Aug 2024: 7,265) in which 2,662 (Aug 2024: 2,800) were Registered Specialist Trade Contractors and 4,485 (Aug 2024: 4,465) were Registered Subcontractors.
		The Executive Director wrote to a total of 43 major private developers, universities, educational institutions, charitable organisations and public utility companies respectively on 18 and 28 October 2024 with the view of promoting the mandatory employment of registered specialist trade contractors in their construction projects. The Secretariat was meeting with the management of these organisations to lobby for their support and would solicit Development Bureau's support.
		The biennial RSTCS Leadership Summit was successfully held on 19 November 2024. The theme of this year was "Set Sail with New Technologies", featuring the sharing of practical experiences of robotics adoption by pioneer subcontractors. There were approximately 820 trade

		associations leaders and management personnel of registered companies participated in-person and online mode.
