Committee on Environment and Sustainability Summary of Meeting No. 003/25

Key Highlights

- 1. Re R&D Fund Project iBEAM Unison Members endorsed KPIs achievements and supported KPI-based payment of HK\$963,900 to Beam Society Limited (BSL).
- 2. Re CIC Sustainable Finance Certification Scheme (SFCS) Members endorsed the suspension of the current SFCS, effective 30 September 2025, and the recommendation to conduct a strategic review latest by 31 March 2027.
- 3. Members approved the proposed composition of the Organising Committee for CIC Global Construction Sustainability Forum and Exhibition (GCSFE) 2026.
- 4. Members noted that the 2026 E&S budget had been revised from HK\$26.31 million to HK\$16.7073 million. Members also noted the updated KPIs related GCSFE 2026. The Secretariat will update the budget plan following the Committee on Administration, Finance, Governance, and Strategy (Com-AFGS) meeting on 19 September 2025, with the possibility of changing the event venue of GCSFE to accommodate the revised budget, if necessary.

Members were briefed on the capacity building activities for the Hong Kong Green Shop Alliance (HKGSA) 2025, which operates on a two-year cycle. Members were updated on the operation of the CIC Green Product Certification Scheme (CIC GPC), including website enhancements, GPC 2.0 pilot run cases, training, promotion plan and current application status. HKGBC reported an amendment to the 2026 KPIs for CIC GPC. The target number of valid licenses has been reduced from 1,400 to 960 due to the anticipated expiration of a significant number of ready-mixed concrete product licenses in the coming year. Additionally, a new KPI has been introduced to increase the number of product categories with more than three suppliers to 18. HKGBC reported the tendering process for the "Market Demand-and-Supply Study" under CIC GPC Enhancement Stage 4 and 5. The study is expected to commence in 2025 and has an estimated duration of 6 to 8 months.
