Key Highlights

- 1. As of 11 September 2025, the Mainland Liaison Services (MLS) Department organised a total of 35 activities related to mainland affairs, including 25 meetings and exchanges, 8 technical visits, 1 mainland recruitment fair and 1 on National Affairs Course. The overall satisfaction rate of the activities reached 96%.
- 2. The business plans related to "technical visits", "business matching sessions", and "issuing the 'China Mainland Construction Technology Booklets" in the Committee on Mainland Affairs (Com-MA) 2025 KPIs have been completed ahead of schedule. In response to changes in industry demand, the Mainland recruitment fair has been adjusted from two sessions to one, and the relevant fair has been completed. Other business plans are proceeding as planned.
- 3. Members proposed to discuss the future development direction of the dedicated committee, suggested continuing to promote connections with the Mainland while collaborating with overseas to address new challenges in the industry. By leveraging Hong Kong's branding and advantages, particularly through the promotion of MiC/MiMEP and professional services, it was suggested to collaborate with Mainland partners to complement each other's strengths and expand opportunities under the Belt and Road Initiative, thereby promoting new growth in Hong Kong's construction industry.
