		(a) Production of the website for the GBA Construction Directory was expected to tender in 2021 Q1.
		(b) Members took note of Task Force's plan to organise GBA study tours on MiC, Alot and DfMA for Building Services in 2021.
		(c) Members took note of the development project at Xiji Island (西基島) jointly developed by the Center
		of Science and Technology & industrialization Development, Ministry of Housing and Urban-Rural
		Development (CSTID) and the Guangzhou Municipal Construction Group. CIC would facilitate the
		exchange and sharing of experience in training and demonstrating innovative technology with the GBA
		counterparts.
4.12		Task Force on Reasonable Consultancy Fee Evaluation System
		Since the tender sum with the highest combined score was higher than the pre-tender estimate. Subsequently, Members approved to increase the budget in November 2020 and the tender was expected to be awarded in 2020 Q4.

		(a) Task Group 1 (BIM Specifications) convened a meeting in early December 2020 to refine and finalise the Exchange Information Requirements (EIR) with BIM Sample Project EIR.
		(b) Task Group 2 (BIM SCC & Services Agreement) would convene a meeting on 14 December 2020 to discuss the first draft of SCC. The Secretariat was reviewing the draft Services Agreements for BIM submitted by LESK Solutions in December 2020 and would then circulate to TG Members for comment.

		TF Members approved to engage a consultant for the study via two-stage tender. The Secretariat issued the firststage invitation for Expression of Interest (EOI) in December 2020.
