- 1.1 The information you provided by means of this form to the Construction Industry Council, its affiliates, and / or its subsidiaries, including, but not limited to, the Hong Kong Institute of Construction and Zero Carbon Building, Construction Sector Imported Labour Quarters Limited (collectively, the "CIC"), including any personal data as defined in the Personal Data (Privacy) Ordinance (Cap.486), will be used solely for purposes related to the activities of the CIC. - c) Performing and exercising functions and powers of the CIC under relevant legislation, rules and sublegislation, including but not limited to the Construction
- Industry Council Ordinance (Cap. 587) and Construction Workers Registration Ordinance (Cap. 583);d) Establishing, exercising and defending the CIC's legal rights, and complying with the CIC's legal and

regulatory obligations (including anti-money laundering obligations, complying with orders by courts or regulators, etc.);

- e) Managing access to the CIC's premises and for security purposes;
