I will be responsible for the indemnification incurred in any damage of machines, tools and equipment resulted from my negligence or willful misconduct during the test/course. I consent to the CIC will not be accountable for any injuries and deaths incurred due to my negligence.
- 3. I understand and agree that the HKCITTC reserves all rights to reject my second test application (i.e. re-sit) where I fail to comply with the HKCITTC regulations and/or to present myself to the tests/courses without a valid justification.
- 4. I understand and agree that the HKCITTC reserves all rights to reject my test/course applications; and to deny my test eligibility; and to discontinue or terminate its service(s) at its sole discretion without any refund/compensation liability. ### Purposes of Collection
