

Specified Form of Emergency Construction Work

Under Section 5 of the Construction Workers Registration (Exemption) Regulation, ("Exemption Regulation") (Cap 583C)

This form is to be used by the controller of a construction site for the purposes of notifying the Construction Industry Council (CIC) of the emergency work and submitting a record of the emergency work pursuant to sections 5(2) &(5) of Exemption Regulation. Please read the "Points to Note" before completing the specified form.

此表格適用於建造工地的主管依據《豁免規例》第 5(2)及(5)條,向建造業議會(議會)呈報緊急工作的進行及提交有關緊急工作的紀錄。 填寫本指明表格前,必須細閱「注意事項」。

Points to Note:

- 1. **Controller** of a construction site, means the principal contractor for the site or if there is no principal contractor for the site, a person who has control over or in charge of the site.
- 2. **Emergency work** means any construction work reasonably required to be carried out immediately on a construction site due to an emergency, for one or more of the following purposes:
 - (a) saving human life;
- (b) preventing personal injury;
- (c) preventing damage to property;
- (d) preventing serious interruption or disruption to a public transport system or utility service.
- 3. Emergency work **in the first 72 hours** upon the controller being aware of the emergency will be exempted from the "designated workers for designated skills (DWDS) requirement.
- 4. Exemption only applies to emergency work that involves the skills of the 47 designated trade divisions set out in Schedule 1 of the Exemption Regulation.
- 5. The controller must notify the CIC of the commencement of the emergency work by completing and submitting **Part A** of this form to the CIC, **within 48 hours** upon being aware of the emergency.
- 6. The controller must also submit a record of the emergency work by completing and submitting **Part B** of this form to the CIC, **within 96 hours** upon being aware of the emergency.
- 7. Please fill in the information as required in **Part** C of this form and return it along with the completed form to the CIC.
- 8. For enquiries, please contact the CIC at 2100 9000.

注意事項:

- 建造工地的主管是指該工地的總承建商,或如該工地沒有總承建商,任何掌管或主管該工地的人。
- 2. **緊急工作**指由於緊急事故、並為達致以下其中一項或多於一項的目的而合理地需要立即在建造工地進行的建造工作:
 - (a) 拯救人命;
- (b) 防止人身傷害;
- (c) 防止財產受損;
- (d) 防止公共運輸系統或公用事業設施服務出現嚴重的中斷或被嚴重地干擾。
- . 由主管知悉緊急事故起計**首72小時**內的緊急工作將豁免受「專工專責」規定規管。
- 4. 該豁免只適用於涉及《豁免規例》附表 1 所載的 47 個指定工種分項的技能的緊急工作。
- 5. 該主管須在知悉緊急事故後的 48 小時內,填妥及交回本表格甲部予議會,以通知議會該緊急工作的展開。
- 6. 該主管亦須在知悉緊急事故後的96小時內,填妥及交回本表格乙部予議會,作為向議會呈交緊急工作的紀錄。
- 7. 請填妥本表格內部並連同其他已填妥的部分一併交回議會。
- 8. 有任何查詢,請致電 2100 9000 聯絡議會。

Personal Information Collection Statement

1. Collection of Personal Data

- 1.1 The information you provided by means of this form to the Construction Industry Council, its affiliates, and / or its subsidiaries, including, but not limited to, the Hong Kong Institute of Construction and Zero Carbon Building, Construction Sector Imported Labour Quarters Limited (collectively, the "CIC"), including any personal data as defined in the Personal Data (Privacy) Ordinance (Cap.486), will be used solely for purposes related to the activities of the CIC. The activity and the required personal data will be detailed in the application form.
- 1.2 Whether or not you provide the personal data by means of this form is voluntary. However, where you are providing information by means of this form for the purpose of an application, it is necessary that you supply the CIC with complete information as specified on the application form. Otherwise, the CIC may be unable to process or consider your application. If the parties are under the age of 18, please consult parent or guardian before providing any personal data to us.
- 1.3 You are entitled to request access to and correction of any errors in your personal data. If you wish to do so, please write to Assistant Director Registration Services (Data Access Request), Construction Industry Council, 38/F COS Centre, 56 Tsun Yip Street, Kwun Tong, Kowloon. 2. Purpose of Collection

- 2.1 The personal data you provided by means of this form will be kept confidential and may be used by the CIC for the following purposes:
 - a) Processing your application and the related matters;
 - b) For all purposes in connection with the CIC's regulation of construction workers personally carrying out construction work on construction sites pursuant to the Construction Workers Registration Ordinance (Cap. 583)
 - c) Facilitating communication between the CIC and the named persons provided by means of this form;
 - Performing and exercising functions and powers of the CIC under relevant legislation, rules and sublegislation, including but not limited to the Construction Industry Council Ordinance (Cap. 587) and Construction Workers Registration Ordinance (Cap. 583);
 - e) Establishing, exercising and defending the CIC's legal rights, and complying with the CIC's legal and regulatory obligations (including anti-money laundering obligations, complying with orders by courts or regulators, etc.);
 - f) Managing access to the CIC's premises and for security purpose;
 - g) Preventing and responding to actual or potential security threats, fraud or illegal activities;
 - h) Handling complaints or enquiries;
 - i) Performing analysis and conducting research and surveys;
 - j) Performing audits and compliance reviews to ensure compliance with the applicable CIC's policies and procedures, regulations and law;
 - k) Other purposes related or incidental to the conduct of the CIC's activities; and
 - l) Any other purposes that you may consent to from time to time.

3. Disclosure and Transfer of Personal Data

- 3.1 The CIC may disclose or transfer the personal data provided by means of this form for the purposes as stated in paragraph 2 to third parties, including but not limited to the following:
 - a) Any or all of the CIC's affiliates and/or subsidiaries listed in 1.1 above;
 - Any third party service providers, contractors/sub-contractors that, on behalf of the CIC, operate or maintain membership, event registration, tour booking, researches and/or analysis, or carry out back-end services, administrative services, verification services, cloud services or information technology services, or provide necessary support or services to the CIC to enable us to provide our services, including any insurance, banking or third party payment gateways services used by the CIC, and any other entities that discharge contractual obligations on our behalf; or
 - c) Any of the CIC's professional advisors, including but not limited to lawyers, accountants and auditors.

- 1.1 你透過本表格向建造業議會、其關聯及/或附屬公司,包括但不限於香港建造學院、建造業零碳天地、建造業輸入勞工宿舍有限公司(統稱「議會」)提供的資料,包括《個人資料(私隱)條例》(第486章)中定義的任何個人資料,只會用於與議會活動相關之目的。具體活動及所需個人資料將在申請表中詳細列明。
- 1.2 你是否透過本表格向議會提供個人資料純屬自願性質。然而,如果你透過本表格提供資料之目的是為了作出 某項申請,你便須向議會提供申請表上所指明的資料。否則,議會可能無法處理或考慮你的申請。如果未滿 十八歲人士,在向議會提供任何個人資料前,應先徵詢父母或監護人。

 - d) 履行和行使議會根據相關條例、規則和附屬法規授予的職能和權力,包括但不限於《建造業議會條例》(第587章)及《建造業工人註冊條例》(第583章);
 - e) 確立、行使或維護議會的法律權利及遵從議會的法律和規管責任(包括打擊洗錢責任、遵從法院或 監管機構的命令等);
