Test Paper for Intermediate Trade Test

Job Title: Building Security System MechanicSkill Level: Medium-skilled worker

Test P1 : Multiple-choice – Ethics and safety measures of the building security industry

Test objective:

To assess candidates' knowledge on the work ethics and safety measures of the building security industry

Test requirements:

Among the safety and ethics questions preset by the test center, the exam venue will draw one set of questions (10 questions), candidates must get 6 or more questions correct to pass.

Points to note:


- Questions are in <u>multiple-choice</u> format, candidate could pick one out of three answers for each question.
- ii) Candidates who do not read Chinese may request to attempt the questions orally.
- iii) The oral test is in Cantonese.
- iv) If candidates could not understand a question, that question could be repeated once only.
- V) To avoid verbal misunderstanding, the central will arrange recording for the oral tests.

Test objective:

To assess candidates' practical skills in "conduit wiring" and "socket installation".

Test requirements:

- (i) Wire two different types of "signal transmission cables" (cat.5 cable and 4-core cable) into the pipe preset by the "test center". (Reference drawing as below)
- (ii) Install a network socket and a telephone socket at the specified locations (Reference drawing as below)
 - Connect two American sockets (RJ11) with a wired signal transmission cable.
 - Connect two network sockets (RJ45) with a wired signal transmission cable according to T568B standard.



Materials: 10 RJ45 and Telephone Line Outlet

- 2 Tele-transmission cable (Cat.5 Cable)
- ③ Telephone signal transmission cable (4-Core Tel Cable)

Test P2-2 : Color identification and handling of multi-core communication cable terminal

Test objectives:

To test candidates' ability in differentiating colors; and

To test candidates' practical skills in installing multi-core connection cables.

Test requirements:


After removing appropriate length of the sheath, connect 10 wires of a 20-core

telecommunication cable to sample wires of the same color at the locations specified on the

couplet. (Reference drawing as below)

Note:

Location and color must be exactly the same as the sample picture below.



Materials: 10 "Multi-coupling socket" Krone block

20-core communication cable

Test objective:

To assess candidates' practical skills in different types of connecting cables.

Test requirements:

Produce three 0.3m connecting cables of different types (length of wire excluding the joint).

First wire: "Standard" broadband signal connecting cable (Cat.5 cable + RJ45 plug). Both ends must satisfy the EIA568B standard.

Second wire: video signal connecting cable (RG59 cable + both ends should connect a welded BNC joint and a cramped BNC joint).

Third wire: 13A power connecting cable (one end connects to a BS1363 plug and the other end remains as it is).

Note:

- (i) All completed connecting cable should meet the test center's requirements. Length error of a cable (excluding the joint) should not exceed 1cm.
- (ii) Candidates are required to test the connecting cables' stability, and use a suitable meter to test whether the cable functions properly.

Materials: ^① Broadband plugs (RJ45) x 2

- ^② BNC joint (cramped) x 1 and (welded) x 1
- ③ Broadband cable (Cat.5 cable) and coaxial cable (RG59)
- ④ 13A power plug (BS1363) x 1
- © 3-core BS6500 power cable

Test P2-4 : Install, wire and connect a simple set of "office visitor monitoring system"

Test objective:


To access candidates' practical skills in <u>installing</u>, <u>wiring</u> and <u>connecting</u> "office visitor monitoring system".

Test requirements:

<u>Install</u>, <u>wire</u> and <u>connect</u> a "office visitor monitoring system" according to the drawing, and use different meters to test whether all components / equipment function properly. (Reference drawing as below)

Note:

Erros in connection (electronic lock, etc.) will damage the electricity supplier. Candidates should therefore be careful.



Materials: ^① Video intercommunication phone for users

- ^② Password input device and card reader
- ③ Electronic door lock (unlock during power outage)
- B Electricity supplier for electronic lock
- S Emergency door check
- [®] Various types of signal transmission cable
- ⑦ Electric cable

Notes to Candidates :

- 1. Candidates should read the test papers carefully and ask the invigilator for any queries.
- 2. Candidates should study the drawings and specifications attached to test papers, if any, before the test begins.
- 3. Candidates should carry out the test according to test papers, working drawings and specifications provided.
- 4. Candidates shall bring their own safety shoes, other safety equipment will be provided by trade testing centre. Candidates must take all necessary safety precautions to ensure work safety.
- 5. All tools and materials required by the test will be provided by trade testing centre, candidates should check and ensure their adequacy and quality. Candidates shall use the tools and materials properly based on trade practice. All the tools must be returned to trade testing centre after the test. The candidates may ask the invigilator for any problems.
- 6. Candidates are required to handle and move the tools and materials for use in the test, and to carry out associated works.
- 7. Invigilator will take record photos periodically during the test.
- 8. Candidates are not allowed to take any photo or video with cameras or mobile phones.
- 9. Candidates are not allowed to use their mobile phones during the trade tests, except for emergency situation.
- 10. The marking scheme is based on the following criteria :
 - a) Understanding of drawing and specification
 - b) Preparation works before commencement of test
 - c) Working procedures
 - d) Accuracy and quality of works
 - e) Progress of works
 - f) Proper handling and use of materials
 - g) Proper use of tools and equipment
 - h) Safety precautions
 - i) Considerate of other trades
 - j) Housekeeping after completion of test
- 11. All candidates must stop when time is up.
- 12. Candidates are required to return the test paper to invigilator after the test.
- 13. Offering bribe to invigilator is an offence in law and trade testing centre will report to the ICAC for any such case.

In the event that the candidate fails to take any necessary safety precautions and / or works in any dangerous situations, he / she will be assessed failed
