<u>Safety First: Construction Industry Council Publishes</u> Safety Alert No. 001/16 Lorry-mounted Cranes Pre-use Checklist

Hong Kong • **22 June 2016** – The Construction Industry Council (CIC) today released a new publication entitled *Safety Alert No.001/16* – *Lorry-mounted Cranes Pre-use Checklist* (Safety Alert).

To increase construction site safety and encourage best practices, the Task Force on Safety of Lorry-mounted Cranes under the CIC's Committee on Construction Safety has prepared this Safety Alert to encourage crane owners and relevant persons to consider thoroughly and comply with the following requirements recommended during different procedures:

- Appoint The owner of a lorry-mounted crane should appoint in writing a
 competent and adequately trained person to carry out a pre-use check of the crane
 with the use of the pre-use checklist before starting the lifting operation of each shift
 or working day.
- Record The owner should ensure that a pre-use check has been carried out with relevant results and properly recorded before starting the lifting operation of each shift or working day.
- Detect and Report In any event, should any defect (such as twisted/broken wires, hydraulic oil leak, etc.) or abnormality in the crane be found, or should the crane be accidentally damaged, the crane should cease to be used and this should be reported immediately to the responsible person concerned.
- Cease and Repair The crane with defects or damage should be taken out of service until all the defects or damage have been rectified.
- Daily and Weekly Apart from the items covered in the daily pre-use check, a full
 inspection of the crane shall be carried out at least once a week

Ms. Ada FUNG, Chairperson of the Committee on Construction Safety said, "We urge crane owners to implement effective monitoring and supervision to ensure the safety of the lorry-mounted cranes before use, which is to appoint a competent person (or operator) to implement the safety checklist and ensure the safety questions regarding the Cab, Outriggers, Crane and any attachments are carefully considered before use. We believe this daily and weekly safety checklist will help to prevent accidents and works towards the goal of using best practices throughout Hong Kong for the safety and betterment of all."

Lorry-mounted Cranes Pre-use Checklist

- 1. The owner of a lorry-mounted cranes ("crane") should appoint in writing a competent person (who may be the crane operator who is competent for the purpose) to carry out a pre-use check of the crane with the use of this checklist before starting the lifting operation of each shift or working day. The owner should ensure that the competent person (or operator) so appointed is adequately trained and capable of discharging his duties safely.
- The owner should ensure that a pre-use check covering not less than those items as specified in this checklist has been carried out with relevant results properly recorded in the checklist before starting the lifting operation of each shift or working day.
- 3. In any event, should any defect (such as twisted/broken wires, hydraulic oil leak, etc.) or abnormality in the crane be found, or should the crane be accidentally damaged, the crane should cease to be used and this should be reported immediately to the responsible person concerned.
- 4. The crane with defects or damage should be taken out of service until all the defects or damage have been rectified, with endorsement given by the responsible person concerned.
- 5. Apart from the items covered in the daily pre-use check, a full inspection of the crane shall be carried out at least once a week by a competent person in accordance with the Factories and Industrial Undertakings (Lifting Appliances and Lifting Gear) Regulations, Cap. 59J. Reference should also be made to the relevant code of practice and guidance notes issued by the Labour Department.

6. In this checklist:

- I. "Owner", in relation to any lorry-mounted cranes, includes the lessee or hirer thereof, and any overseer, foreman, agent or person in charge or having the control or management of the crane, and the contractor who has control over the way any construction work which involves the use of the crane is carried out and, in the case of a crane situated on or used in connection with work on a construction site, also includes the contractor responsible for the construction site.
- II. A contractor is responsible for a construction site if he is undertaking construction work there or, where there is more than one contractor undertaking construction work at the site, if he is the principal contractor undertaking construction work there.
- III. "Competent person" means a person who is appointed by the owner, and by reason of training and practical experience, competent to perform the duty assigned.

- 2. The most recent two checklists should be kept in the crane and made available for inspection.
- 3. Compliance with this checklist should not be regarded as exhausting those matters which need to be covered by the relevant safety legislation, nor are they intended to relieve persons undertaking the work of their statutory responsibilities. It is important to note that compliance with this checklist does not of itself confer immunity from the legal obligations.
